SIDE EVENT PROPOSAL

At the thirty-sixth session of the Economic Commission for Latin America and the Caribbean (ECLAC), held in Mexico City in 2016, the member States adopted resolution 700 (XXXVI)¹, Mexico Resolution, which established the Forum of the Countries of Latin America and the Caribbean on Sustainable Development as a regional mechanism to follow up and review the implementation of the 2030 Agenda for Sustainable Development, including the Sustainable Development Goals and targets, its means of implementation, and the Addis Ababa Action Agenda.

It is convened under the auspices of ECLAC and guided by the principles established for all follow-up and review processes by the 2030 Agenda for Sustainable Development, adopted in September 2015 by the United Nations General Assembly². It involves States, the private sector and civil society, as well as subsidiary bodies of ECLAC, development banks, other United Nations agencies and regional integration blocs.

In consultation with the Government of Argentina, in its capacity as Chair of the Forum of the Countries of Latin America and the Caribbean on Sustainable Development, the sixth meeting of the Forum will be held from 25 to 28 April 2023 at the headquarters of the Economic Commission for Latin America and the Caribbean (ECLAC) in Santiago, Chile. On 25 April, from 9:00 a.m. to 1:00 p.m., will take place the Meeting of the Mechanism for civil society participation in the Sustainable Development Agenda and in the Forum of the Countries of Latin America and the Caribbean on Sustainable Development.
