## BACKGROUND: THE UNITED NATIONS DEVELOPMENT SYSTEM REFORM AT THE REGIONAL LEVEL



### The Framework:



### ECOSOC Resolution E/RES/2020/23 (July 2020)

Following its 2020 Operational Activities Segment, the **United Nations Economic and Social Council (ECOSOC)** adopted resolution E/RES/2020/23 in July 2020, endorsed in General Assembly Resolution 74/297, which, inter alia:

- 1. Requests the Secretary-General to continue to conduct and rely on, in the course of the implementation process, transparent and inclusive United Nations consultations with all countries concerned at all levels, in particular the countries of the region through further deliberations of the ECOSOC with input from existing processes within regional economic commissions and other United Nations regional assets to ensure that the longer-term reprofiling and restructuring of the regional assets of the United Nations be addressed on a region-by-region basis and in accordance with the region's specific needs and priorities.
- 2. Reaffirms that the regional repositioning be conducted with the support of regional economic commissions, specialized agencies, funds, programmes, and regional offices of the Development Coordination Office, while preserving and reaffirming their respective roles and mandates.
- 3. Looks forward to further deliberations in the ECOSOC operational activities for development segment, and requests the Secretary-General to continue regular follow-up, monitoring and reporting, including to the ECOSOC operational activities for development segment.

## The Secretary-General's five recommendations to guide the restructuring of the United Nations development system

- I. Creation of United Nations **regional collaborative platforms** that would absorb existing duplicative coordination mechanisms and foster collaboration on sustainable development among United Nations development system entities operating at the regional level.
- II. Establishment of strong **knowledge management hubs** in each region by pooling policy expertise currently scattered across various entities.
- III. Enhance **transparency and results-based management** at the regional level, including through annual reporting on United Nations system-wide results at the regional level in support of the 2030 Agenda.
- IV. Launch of a region-by-region **change management process** to consolidate existing capacities with regard to data and statistics.
- V. Identification of administrative services that could be provided more efficiently to regional offices through common back offices, similar to efforts that have been made at the country level.

## OVERVIEW OF KEY REGIONAL DEVELOPMENT CHALLENGES





Development challenges in 2023 were driven by a significant slowing economic growth in most countries

Drivers included inflationary pressures, tightening financing conditions, as well as legacy structural weaknesses.

- Low growth, inflation, and rising global borrowing costs have pressured governments to increase fiscal constraints and curtail public spending in areas related to the SDGs.
- Vulnerable populations are suffering disproportionately. 13.1% of the population lives in extreme poverty.
- Structural weaknesses, including high labour market informality and weak, fragmented health and social security systems limits comprehensive access to basic services and social protection to a significant proportion of the population.
- The region's current political and governance systems have been challenged to effectively respond to the needs and expectations of the population.
- Socioeconomic challenges are compounded by vulnerability towards disasters and the impacts of climate change (i.e. rising sea levels, increasing temperatures, and changes in rainfall patterns).

Results were achieved through the IBCs and working groups in response to RCs and UNCTs requests for support.

### Types of support provided in 2022

- Providing cross-border, subregional, and regional support through integrated analysis and policy advice, and normative guidance.
- Providing regional common goods through evidence-based policy guidance, knowledge resources, and capacity building.
- Foster regional coherence by facilitating alignment with global agendas.
- Promoting public awareness through communications and joint positioning and advocacy.
- ☐ Facilitating multi-stakeholder partnerships for sustainable development.



## Regional level system-wide results Support to UNCTs



**System-wide quality assurance:** The **Peer Support Group (PSG)** provided guidance and quality assurance support on the various stages of designing CCs and CFs.

- Training workshops completed for eight countries implementing their CFs in 2023.
- PSG members from 30 entities facilitated workshops and consultations between governments, UNCTs, and other stakeholders.

**Cross-regional coherence:** Two cross-regional dialogues held with PSGs from Africa, Europe and Central Asia to share country experiences, lessons learned, and good practices in CF processes.

**Increased efficiency:** Efficiency reporting via the Business Operations Strategy (BOS) 2.0 platform began — regional costa avoidance estimates increased from US\$ 15.8 million in 2021 to US\$ 25.3 million in 2022 for five years.



## Regional level system-wide results Engagement with Stakeholders



The RCP LAC has engaged with a **series of key stakeholders** at the regional level to **better support Member States** in advancing the implementation of the **2030 Agenda**.

- Established a Partnership Task Force to scale up regional partnerships particularly on emerging issues such as food systems, energy transition, and digitalization.
- Strengthened multi-stakeholder networks and participation in intergovernmental meetings, such as the fifth meeting of the Forum of the Countries of Latin America and the Caribbean on Sustainable Development.
- Participation in existing subsidiary bodies and intergovernmental of the Regional Commission jointly organized with other UN entities to reflect on the progress made and challenges faced in the implementation of the 2030 Agenda in synergy with regional agendas.

### 2023 RCP LAC Priorities



2023 marks the mid-point in implementing the 2030 Agenda for Sustainable Development.

The RCP LAC will step up efforts to provide integrated and coordinated support from the United Nations to countries of the region to achieve the 2030 Agenda. An enhanced RCP LAC — "RCP LAC 2.0" — will facilitate timely and targeted responses.


